#### 13. <u>Topics for Discussion:</u>

13.1 Extreme Weather Policy Documents: 5-F-24 Extreme Weather Policy

The Board discussed the Extreme Weather Policy and changes. The Board considered the Extreme Weather Policy needed to be specific about decisions regarding school events when a storm and lightning is forecast. The revised policy to be tabled at the next meeting.

#### 13.2 School Vandalism

A number of incidents involving vandalism of student toilets have occurred during the term. The Board questioned the school's response to the situations. The school investigates individual cases of vandalism and has been successful in identifying the perpetrator in most situations. In these circumstances consequences are applied, and the attempt is to utilise 'natural consequences' for behaviour. Situations are dealt with differently in secondary compared to junior primary toilets. The Board requested data on the number of incidents and resolution.

After a discussion on solar panels, the process for installing solar panels under the Department of Education was explained.
